

BLACKLICK CREEK WATERSHED ASSOCIATION, INC. CONTRACTUAL CONSENT OF LANDOWNER

(I) (We), the undersigned, being the owner(s) of _____ Acres of land located in Blacklick Township Cambria County, identified as Tax Parcel #06-11-105.1 as (Township, Borough, City) (County)

described in the deed(s) recorded in the Recorder of Deeds Office Book(s) and page(s) _____ and shown by crosshatched lines on the map attached hereto which is signed in the original by the landowner upon which Blacklick Creek Watershed Association, Inc. proposes to engage in activities for the reclamation of land and waters affected by mining and other operations, HEREBY ACKNOWLEDGE THAT BLACKLICK CREEK WATERSHED ASSOCIATION, INC. AND ITS OFFICERS, AGENTS, EMPLOYEES, CONTRACTORS AND SUBCONTRACTORS HAVE THE RIGHT TO ENTER UPON A USE THE LAND FOR PURPOSES OF RESTORATION, RECLAMATION AND/OR REMEDIATION ACTIVITIES. Such restoration, reclamation and/or remediation activities may include, but not necessarily be limited to, installation of water treatment systems, surface reclamation, revegetation, refuse removal and/or processing and other activities intended to reclaim/restore the land and waters.

Furthermore (I) (We), the undersigned do hereby irrevocably grant to the BLACKLICK CREEK WATERSHED ASSOCIATION, INC., and to the COMMONWEALTH OF PENNSYLVANIA, the right to enter upon the aforesaid land before beginning the activity(ies), during the activity(ies) and for a period of five (5) years after the completion of reclamation/restoration activity(ies) for the purpose of studying, inspecting, planting and necessary additional reclamation or restoration activities in accordance with the Clean Streams Law, the Coal Refuse Disposal Act, the Surface Mining Conservation and Reclamation Act, the provisions of the Environmental Stewardship and Watershed Protection Act and the provisions of the Environmental Good Samaritan Act, as amended, rules and regulations promulgated thereunder, and the provisions of permit(s) issued to Blacklick Creek Watershed Association, Inc. (I) (We) do hereby grant in addition to the Commonwealth, for the aforesaid period of time, a right of entry across any adjoining or contiguous lands owned by (us) (me) in order to have access to the land described herein. It is specifically agreed and understood that this contractual consent gives the Commonwealth the right to enter, inspect, study, backfill, plant and reclaim the land and abate pollution therefrom as a matter within the police power but does not obligate the Commonwealth to do so, and does not constitute any ownership interest by the Commonwealth in the aforesaid land.

This Consent shall not be construed to impair any contractual agreement between the Blacklick Creek Watershed Association, Inc., its agents, contractors or subcontractors and the landowner.
