UNITED STATES STEEL CORPORATION, a Delaware corporation, hereinafter referred to as the "Steel Corporation,"

COMMONWEALTH OF PENNSYLVANIA, hereinafter referred to as the "Commonwealth";

WITNESSETH: That, for and in consideration of the sum of One Dollar (\$1.00) in hand paid by the Commonwealth to the Steel Corporation, the receipt whereof is hereby acknowledged, the Steel Corporation does hereby grant to the Commonwealth the following:

- (1) The right to install, maintain and remove a concrete block wall in the drift opening of the Dunkirk Mine situate in Carroll Township, Washington County, Pennsylvania, the location of said drift opening being shown on print marked Exhibit "A" attached hereto and made a part hereof;
- (2) The right to install, use, maintain and remove a pipe of a maximum diameter of 24 inches in and across land situate at said Dunkirk Mine at the location shown in red on Exhibit "A."

The Commonwealth shall refill and level all excavations made by it and shall restore the land as nearly as practicable to the original condition at its cost and expense.

The Steel Corporation reserves the right to use said land and drift opening. In the event the Steel Corporation shall remove said wall or a part thereof for use of said drift opening, the Steel Corporation shall replace said wall at its expense when its use of said opening is terminated.

In the event the Commonwealth shall remove said pipe and shall not replace it within a period of one (1) year from the date of removal, the rights herein granted shall terminate.

This grant is made subject to easements and licenses shown by instruments of record or apparent on the land.


